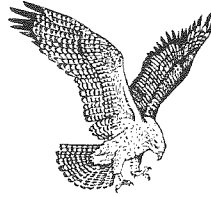

Dear A-C Valley Families,

The USDA (United States Department of Agriculture) has provided waivers for school districts nationwide to provide free meals to students during the COVID-19 pandemic. At this time, the district has received guidance from PDE (Pennsylvania Department of Education) to participate in either the SSO (Seamless Summer Option) and/or SFSP (Summer Food Service Program). The district will be filing the appropriate paperwork with PDE (Pennsylvania Department of Education) effective immediately. The district will be operating their normal NSLP (National School Lunch Program) and SBP (School Breakfast Programs) under the SSO (Seamless Summer Option) effective Monday, September 14<sup>th</sup> 2020. This program will allow the district to provide two free meals a day to its remote and face to face instruction students. A-C Valley School District will provide free breakfast and lunch for these students through December 31<sup>st</sup>, 2020.

I encourage families to visit the school webpage at <https://www.acvsd.org/Page/39> and/or the School Cafe webpage at <https://www.schoolcafe.com/> to complete the free and reduced meal application. This will allow benefits for households to remain current in the instance the program is not offered after the December 31<sup>st</sup>, 2020 deadline. Keeping meal benefits current will help eliminate unwanted charges to student accounts. More information about cafeteria operations can be found on the Allegheny-Clarion Valley School District webpage. I look forward to making this transition as easy as possible for all families. If there are any questions or concerns, I encourage you to contact me for further clarification. I want to thank you for continuing to allow me to serve the Allegheny-Clarion Valley School District and your continued support for the food service program.
