Executive Session for Personnel held via remote on Monday, March 30, 2020, beginning at 5:30 P.M.

Approved to suspend Policy #006.1 - Attendance at Meetings Via Electronic Communication.

Approved the minutes of the Revised Workshop/Regular Board Meeting held on March 16, 2020.

Approved the designated assigned and unassigned 2019-2020 Fund Balance Report as attached.

Discussion held related to the 2020-2021 budget.

Accepted the letter of resignation from Lydia Thompson, High School Studyhall Monitor, effective March 9, 2020.

Accepted the letter of retirement, effective at the end of the 2019-2020 school year from Jennifer Barr. Jennifer has been an employee with the district since August, 1992.

Approved a 7th & 8th Grade Math Lab for the 2020-2021 school year.

Approved the request from John Irwin and the A-C Valley Boys' Baseball team to begin the process of scheduling spring training in Florida for the spring of 2021 (in order to get discounted rates), barring any pandemics that may arise in the future. It is a requirement that Travel insurance must be purchased for this trip.
